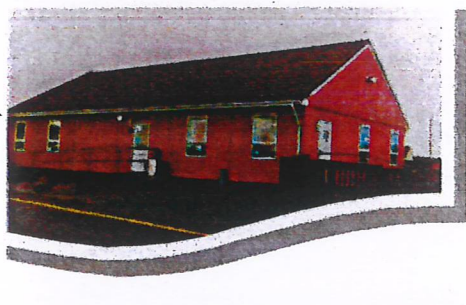

It should be noted that services and activities offered are dependent on the availability of funding and the capacity and resources of the organisation. However if we identify a need for a new project or a new development to an existing project we will work very hard to source funding and build capacity to meet that need.

Monitoring arrangements

Annual milestones and targets will be agreed and annual presentations will be made to the Members and other stakeholders, partners, etc at the AGM.



How we got here:-

- In 2009 The Board of Directors at that time identified that they had completed their current mandate and it was time to go back and ask the community, partners and stakeholders what we should do next.
- In 2011 Ormlie Community Action plan was published
- Since then updates to the Action Plan have been reported to the AGM
- At the AGM in January 2016 it was agreed that a new 3 yr Development Plan would be drawn up
- The foundation of the new plan would be the Action Plan 2011-2016, current areas of work , and the current economic landscape.
- We would consult with our members, our clients/participants, partners / stakeholders and the wider community.
- It was also noted that any future activities would be constrained by funding available.
- In June 2016 a survey monkey was circulated asking for information on the importance of the various activities we offer and the outcomes we hope to achieve.
- The results of this survey gave an overwhelming approval for the activities and outcomes which form the basis of this plan.
- The draft plan was circulated amongst OCA Ltd members, partners, and users for comments.
- The Plan was presented at the AGM in Nov 2016.
